## **General Tournament Information**



- Divisions:** 5th-8th Grade Boys
- Entry Fee:** \$175/team, Registration deadline: Dec. 23rd  
\* Online Registration is available on our website at [www.wisportsservices.org](http://www.wisportsservices.org). Hover over the Basketball tab, click on Super Savers in the drop-down menu to access links to online registration.
- Format:** Three games guaranteed. Ideal format allows teams to play three games in six hours, with a one hour break between each game. Timing factors are two 20-minute running halves with last two minutes of each half being stop time.
- Awards:** Individual awards for 1st & 2nd Place
- Rules:** WIAA Rules with modifications. Complete set of rules available on WSS website, [www.wisportsservices.org](http://www.wisportsservices.org).
- Eligibility:** Only school & community-based teams are eligible, **no All-Star or AAU teams allowed.**
- Concessions:** Provided by the host, no carry-ins of food or beverages allowed.

### **Tournament Check-in procedure:**

- Team Check-in is located at the designated Tournament Headquarters. See team entry form for designated Tournament Headquarters.
- Please check-in with the Tournament Director at least 30 minutes prior to your first game.
